

**OFFICIAL RULES**  
**Tricolor Auto's 2017 Nissan Sentra Giveaway**

The Tricolor Auto 2017 Nissan Sentra Giveaway (the "Giveaway") is sponsored by Tricolor Auto Group, LLC ("Tricolor Auto", "we", "us", "Sponsor"). Tricolor Auto and its affiliates, and any other companies or agencies associated with the Giveaway (such as advertising, promotion, prize providers, fulfillment or judging agencies), together, hereinafter will be referred to as the "Giveaway Entities."

Participation in the Giveaway constitutes the entrant's ("you" or "your" or "entrant") full and unconditional agreement and acceptance of these Official Rules including the decisions and interpretations of Tricolor Auto and/or judging agencies, which are final on all matters relating to the Giveaway.

**1. NO PURCHASE, CONTRIBUTION OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS GIVEAWAY. VOID IN FLORIDA, NEW YORK AND RHODE ISLAND AND WHERE PROHIBITED.** The Tricolor Auto **2017 Nissan Sentra** Giveaway (the "Giveaway") begins at 12:00:01 a.m. Central Time on November 6, 2017 and ends at 11:59:59 p.m. Central Time on December 6, 2017 ("Giveaway Period"). Please read these Official Rules ("Official Rules") before entering the Giveaway.

**2. ELIGIBILITY:** The Giveaway is open to residents of the United States and the District of Columbia, except for Florida, New York and Rhode Island (the "Eligibility Area") who are 18 years of age or older at the time of entry and have the ability to enter into valid contracts in their personal jurisdiction of residence. To be eligible for automatic entry, you must have purchased a vehicle from Tricolor Auto at one of its dealerships located in Texas between November 1, 2007 and November 30, 2017 and not have defaulted on your purchase or financing contract that resulted in a loss or repossession of the vehicle. To receive an entry without purchase, a participant may submit a "no purchase necessary" alternate method of entry by mail during the Giveaway Period. See Rule 4 for full entry details. Only individuals may enter; no entry from any corporation or other entity shall be accepted. Before taking possession of the vehicle (defined below), the winner assumes responsibility for all applicable insurance fees and any costs incurred in claiming or using the vehicle. The Giveaway is VOID outside of the Eligibility Area and where otherwise taxed, prohibited or restricted. Employees of Tricolor Auto and the employees' family members are not eligible to participate in the Giveaway. By participating in the Giveaway, you agree to these Official Rules and to the decisions of Tricolor Auto, which are final and binding in all respects.

**3. ODDS OF WINNING; PRIZES:** Odds of winning are determined by and depend on the total number of eligible entries received per Texas region (DFW, San Antonio, Austin, Odessa, and Houston). A purchase of a vehicle from Tricolor Auto will not improve your chances of winning.

A. Grand Prize. One (1) grand prize will be awarded: a 2017 Nissan Sentra (the "vehicle"). The vehicle will have up less than 500 miles on the odometer. The approximate value of the vehicle is \$15,799.00. Tricolor Auto will pay any expenses related to taxes or title on the vehicle. Winner will be responsible for all applicable insurance and any other expenses associated with acceptance and/or taking delivery of the vehicle. The winner must take delivery of the vehicle no later than December 20, 2017 at Tricolor Auto, 1111 W. Mockingbird Lane, Suite 1500, Dallas, Texas, 75247 or pay by that date to have the vehicle delivered to winner's location. By accepting the vehicle, the winner waives the right to assert, as a cost of winning the vehicle, any and all costs of redemption or travel to redeem the vehicle, and any

and all liability that might arise from redeeming or seeking the vehicle. Winner accepts all responsibility for registering the vehicle.

- B. Small Prizes. Five (5) small prizes will also be awarded. Each small prize will include: (1) entry into the grand prize drawing (the “grand prize drawing”), (2) transportation to Dallas from the 48 contiguous United States or District of Columbia, (3) \$125.00 to cover the cost of one night of hotel accommodations, (4) \$200.00 in spending money, and (5) an invitation to attend Tricolor Auto’s annual holiday party.

**4. HOW TO ENTER:** There are two ways to enter the Giveaway during the Giveaway Period:

- A. Automatic Entry Based on Past Purchase. To be eligible for automatic entry into the Giveaway, you must have purchased a vehicle from Tricolor Auto at one of its dealerships located in Texas between November 1, 2007 and November 30, 2017 and not have defaulted on your purchase or financing contract that resulted in a loss or repossession of the vehicle. All persons eligible for automatic entry will be entered into the Giveaway automatically. If more than one person entered into the purchase or financing contract for the vehicle, both the buyer and any co-buyer will be automatically entered.
- B. Free Entry. To enter the Giveaway without a past purchase, send a letter providing your name, phone number and physical address to us at Tricolor Auto Group, LLC, Attn: Tricolor Auto 2017 Nissan Sentra Giveaway, 1111 W. Mockingbird Lane, Suite 1500, Dallas, Texas 75247.
- C. Limits. No changes to any entry materials or information are permitted once the entry has been submitted. All entries become the property of Tricolor Auto and will not be acknowledged or returned. **LIMIT ONE ENTRY PER PERSON. A PURCHASE OF A VEHICLE FROM TRICOLOR WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

**5. PRIZE DRAWING:** All eligible entries will be divided by region (DFW, San Antonio, Austin, Odessa, and Houston) and Tricolor Auto will randomly select the five small prize winners, one per region, from all eligible entries on December 7, 2017. Tricolor Auto will contact the small prize winners and request their presence at the holiday party on December 12, 2017. Each potential small prize winner must accept his/her prize within 24 hours of notification by Tricolor Auto. If, for some reason, a potential small prize winner chooses not to accept his/her prize, an alternate small prize winner will be chosen within 24 hours of the original potential small prize winner declining the small prize. The five small prize winners who accept the small prize (the “Finalists”) will then be entered into the grand prize drawing. The grand prize winner will be selected by a random drawing to be held at Tricolor Auto’s holiday party, located at 1930 Pacific Ave, Dallas, Texas 75201 on December 12, 2017 at 9:00 p.m. Central Time. The Finalists will each draw one of five (5) keys from a container. The key that opens the vehicle door will be the winner of the Giveaway. **ALL FINALISTS MUST BE PRESENT TO WIN THE GRAND PRIZE.** Tricolor Auto will notify the potential grand prize winner at the drawing during the holiday party, and he/she will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release. If the initially selected winner is ineligible, fails to sign and return the Affidavit of Eligibility and Liability/Publicity Release or fails to claim the vehicle, the vehicle will be forfeited and an alternate winner will be selected. We will select an alternative potential winner from the Finalists within 48 hours of the drawing. The grand prize will be awarded “AS IS” and **WITHOUT WARRANTY OF ANY KIND**, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). The grand prize will be awarded only on winner validation and verification by Tricolor Auto. use and publish their proper name and state of residence in connection with the Giveaway. By participating, the winner releases the Giveaway Entities, their respective officers, directors, employees, advertising, promotion, fulfillment, marketing agencies, public relation firms, consultants or contractors from any and all liability, claims or actions of any kind whatsoever for injuries, damages or losses to persons (including death) and property which may be sustained in connection with the receipt, ownership, possession, acceptance, enjoyment, use or misuse of a prize, or arising out of participation in this Giveaway, or while preparing for, participating in, and/or traveling to and from taking delivery of a prize or any prize-related activity. Should there be a conflict between the laws of the State of Texas and any other laws, the conflict will be resolved in favor of the laws of the State of Texas. Each entrant waives any and all objections to jurisdiction and venue and hereby submits to the jurisdiction of those courts. Any and all lawsuits or other disputes that arise relating to this Giveaway must be filed within one (1) year from the date that the winner is drawn. The failure of the Giveaway entities to exercise or enforce any right or provision of these Official Rules will not constitute a waiver of such right or provision.
